Mileto reviewed historical data and explained 1/1/2024 projection and process. Estimated increase for the PPO medical plans is projected to be approximately 5.50% and for HMO medical plans to be approximately 5.10%. This may change as there are a couple more months to include before the renewal is released. GIN has a healthy reserve balance so that will be a part of the discussion when determining increase when the renewal is presented. Claims activity has increased in 2023.

12. Discussion Item: Compliance and Other Updates

Mileto and Johnson reviewed Compliance Updates including the ending of the Public Health Emergency for COVID-19 on 5/11/2023. Also noted was possibility of Wellness Virtual Fair and reminder of Mental/Behavior Health benefits available through GIN medical plans and Basic Life Employee Assistance Program.

13. Discussion Item: Administration Updates

Remmenga provided update on termination of the BenefitElect system contract with the last weekly feed being sent on Friday, June 16th. The PCORI fee filing will be due on 7/31/2023 at \$3.00 per PPO covered life. Information will be sent out to membership once the IRS has updated the 720 form for 2nd quarter, 2023.
