11. Discussion Item: Mental Health Parity Comparative Analysis

Mileto noted Compliance has confirmed GIN can opt out of this analysis since GIN is a government nonfederal plan. This will save on cost at this time and can be reviewed as needed after the next renewal.

12. Discussion Item: Administration, Compliance, and Other Updates

Remmenga noted claims activity through March, RxDC reporting for 2024 has been completed for BCBS to file, and the First Responder Mandate for joint (member & spouse) mental health therapy services to have a \$0 cost share will go into effect as of June 1, 2025, on the PPO \$300, BCO, and PPO \$750 plans. This mandate is not anticipated to have any major impact on GIN claims.

13. Discussion Item: BCBS Pre-Renewal Review for 1/1/2026 and Reserve Balance

Mileto reviewed the pre-renewal forecast and provided a detailed analysis of the substantial claim activity in the past 16 months. Several options were discussed for GIN to consider as a part of the renewal process to control ongoing costs particularly with prescriptions.

President Carroll noted his appreciation to Ralph Schultz from Forest Preserve District of Will County for his contributions and bringing the Forest Preserve into GIN. All wished him the very best in his upcoming retirement.

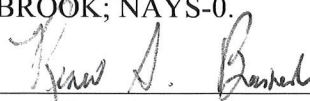
