8. Discussion Item: Renewal Presentation for 1/1/2026 and Reserve Update

Mileto reviewed available information from the initial 1/1/2026 BCBS renewal which shows very high increases required to fund expected claim cost. In addition, due to the substantial loss for FY2025 an additional reserve funding may be required to fund claims as premium increases won't go into effect until 1/1/2026. It was requested to go out to market to other carriers to pursue all possible options for cost containment. Plan change factors will be compiled to have different alternatives at the August meeting.

9. Discussion Item: FY2026 Draft Budget Options

Remmenga reviewed the initial FY2026 Budget Draft based on available renewal information and factoring in the large loss from FY2025. The Budget Draft will be updated for the August meeting with additional renewal data received for discussion.

10. Discussion Item: Administration, Compliance, and Other Updates

Remmenga reviewed claims data through June and noted audit and actuarial review for FY2025 are in process. There is a new Illinois law requiring parents and stepparents are eligible for enrollment if meeting dependent IRS guidelines. This is mandate for the HMO and still pending whether optional or mandated for the PPO plans. Further updates will be provided once available.
