6. Action Item: Revised Renewal Presentation for 1/1/2026

President Carroll started discussion noting the cost increase from GLP-1's along with High Claimants. It was discussed, if possible, to still consider Alternative 2 presented to try and control costs with a change to moving GLP-1's to the existing HDHP's instead of only in a new HDHP. The Board discussed all information presented.

VILLAGE OF FRANKFORT SECONDED THE MOTION.

Remmenga noted the need to approve other required renewal decisions.

CITY OF ELMHURST MOVED TO AMEND MOTION TO APPROVE RENEWAL FOR 1/1/2026 ALTERNATIVE #2 WITH CHANGES PRESENTED ADDING THE SAME COPAY CHANGES TO PPO \$300, CHANGING TO HAVE GLP-1'S ONLY OFFERED IN THE EXISTING 2 HDHP'S REMOVING FROM ALL OTHER PLANS, AND ADDING ADDITIONAL HMO BA PLAN AS PRESENTED AND TO INCLUDE THE FOLLOWING RENEWAL DECISIONS FOR 1/1/2026:

- NO, TO ADDING PARENT/STEEPARENTS TO ELIGIBILITY

- NO, TO ADDING MAVEN
- YES, TO ADDING FIRST STOP HEALTH
- NO, TO ADDING HINGE HEALTH
- YES, TO OFFERING VOLUNTARY WORKSITE BENEFITS THROUGH THE HARTFORD BY LOCATION CHOICE
- YES, CONTINUING MMA RX SOLUTIONS FOR REVIEW OF PHARMACY CONTRACTS
- DENTAL INCREASE OF 2.6% AS SHOWN

The Board discussed information presented.


